******************** AN IN-DEPTH STUDY OF THE DOMESTIC SPEED POST MARKINGS OF INDIA * ************************

Introduction

In the study of Indian Postal History, the handstruck markings of the pre-adhesive period prior to 1852, and the early Indian Cancellations and Postmarks from 1852 to 1900, are indeed very interesting. interesting should be the modern postal markings, including of the Speed Post.

With effect from 1 August 1986, the Speed Post service was introduced to ensure a new, fast, secure and highly reliable service offering guaranteed time bound delivery. In this service, registered letters and parcels were being delivered within 24 hours in Delhi, Bombay, Calcutta, Madras, Ahmedabad, Bangalore and Hyderabad. The sender of such letters and parcels was, however, required to pay a surcharge of Rs.10 for distances up to 500kms and Rs.20 beyond 500kms in addition to the usual postage and registration charges. The surcharge would be refunded in the case of failure to deliver the article within 24 hours. Also, with effect from 1-8-86, daily International Speed Post service was introduced connecting Delhi, Bombay, Calcutta and Madras with the United Kingdom and Hong Kong, which was later extended to the United States of America, West Germany and Japan.

In 1989, this service was expanded to include 56 cities in India (Appendix 'A') and to 35 countries of the world (Appendix 'B'). With effect from 21-3-1991, this service has again been extended to 42 countries (Appendix 'C'). Articles which can be sent by Domestic Speed Post include letters, book packets and parcels. In the International Speed Post service, articles which can be sent include two-fold documents and merchandise, business and commercial documents including cheques, legal documents, computer data like discs, magnetic tapes, punched cards etc. Dutiable items can be sent with proper declaration.

The Tariff rates were modified in 1989 and these are given in Appendix 'D'. The rates were further modified on 11-6-1990 as well as on 1-12-1990, and these are given in Appendices 'E' and 'F' respectively.

Speed Post markings proper

This study has been prepared based on the examination of only Domestic Speed Post markings for the period 12-7-1988 to 8-3-1991, on as many as 282 Registered covers, and has been broadly classified into 6 different Groups or categories. These are:

- Group 1: Those Speed Post covers affixed with only stamps;
- Group 2: Those Speed Post covers having regular or usual meter franking;
- Group 3: Those Speed Post covers having special Speed Post markings;
- Group 4: Those Speed Post covers affixed with a Registry/Calculating machine label;
- Group 5: Those Speed Post covers having Deposit Account markings
- Group 6: Compound Speed Post covers.

Before embarking on the various Groups, I wish to elucidate on the following common features of all Domestic Speed Post covers. first and foremost mark is the one normally seen on the top of the letter proper, preferably in the centre. This is referred to in this article as the HEADING. Most of these headings are in English (Fig.1 to 6 & 8) and very scarcely in a bilingual heading (Fig.7). These headings are normally in red or purple, and sometimes in black. The headings seen are Speed Post, EMS Speed Post, Domestic Speed Post etc. the Speed Post CACHET. These are normally applied on the left hand bottom corner of the cover and are rectangular in shape (Fig. 9 to 17) and are in English. They have 3, 4 or 5 lines, as illustrated, showing Registered Letter No. (RL...), or No...., Date and Weight (WT...) etc. These cachets are generally purple or red in colour, and are also observed without any enclosures. Some covers posted after the stipulated time in the evening have also special markings 'Too Late for Today's Despatch' in one or two lines.

GROUP 1: As mentioned above, this Group consists of Speed Post covers sent affixed with stamps. In these, apart from the headings and cachets, all the stamps have purple, red or black postmarks (Fig.18 to 21). Total number of covers seen by me - 87 Registered Speed Post covers. Earliest is dated 27-5-88, sent from Dadar H.P.O., Bombay 400 014, and the latest from Vijayawada, Andhra Pradesh and Madurai in Tamil Nadu. The details of each type of Circle and Post Office marking are given in Table I, as well as details of the cachets. Total Post Office markings are 30 in number.

GROUP 2: This Group consists of Speed Post covers having Usual or Regular Meter Franking, mostly in red, but also in purple, apart from the heading and cachet. Number of covers seen - 75, pertaining to 28 Speed Post Offices. Some of the important types of Meter Frankings seen are shown in Figures 33 to 38. As will be seen from the details shown in Table II, the meter frankings have been done directly on to the covers, or alternatively they have been first franked on a paper, and this paper has then been affixed on to the cover. In Fig.33, the rate is shown as Rs.6.50, which is a marking on a compound cover (see details under Group 6, Fig.39).

GROUP 3: This is a modified version of Group 2, in which instead of the usual meter franking, the words Speed Post have been inserted in the franked portion. Only a total of 3 covers have been seen by me. In Fig.30, the words 'Speed Post' appear in the advertisement portion of the meter franking. This cover is dated 12-7-88 and is from Dadar H.O. in Bombay. In Fig.31, the words 'Speed Post' appear in the top portion of the circular marking on the left of the Duplex franking (similar to that shown by Dr. R. Gandhi on page 43 'India Post' Jan/Mar 1991, but there 'Speed Post' appears in the bottom portion). The cover is from Meerut City in Uttar Pradesh, and is dated 24-4-1990. In Fig.32, the words 'Speed Post' appear in the right hand top portion of the Duplex meter franking (also shown by Dr. Gandhi). These types of Speed Post meter franking appear to be used somewhat scarcely, compared to the conventional meter franking.

GROUP 4: This Group consists of Speed Post covers having Registry/Calculating Machine labels affixed (Fig.22 & 23). The labels are usually white and the machine calculations are seen in red, black and purple. Total number of covers seen by me-104, pertaining to 6 Post Offices. The details are as under:

GROUP 5: To this Group belong those Speed Post covers having Deposit Account markings, indicating therein that all those persons/companies posting letters at these post offices have special Speed Post Deposit Accounts in the post offices and these get debited from time to time. Some of these markings are shown in Figures 24 to 29. Total number of covers seen - 11, pertaining to 5 Speed Post counters. The colours of these markings are usually red or purple. The details of post offices are:

GROUP 6: This Group consists of those covers which have a combination of two types of Speed Post markings and these are referred to here as 'Compound Covers'. Total number of covers seen - 2 only. One has been sent from Trivandrum G.P.O., dated 12-3-1990 and has stamps to the value of Rs.28/10 affixed as well as a Registry/Calculating Machine label (see Fig.40). The other cover has stamps as well as Meter franking., dated 20-4-1990 and sent from Ahmedabad G.P.O. The value of the stamps is Rs.20/- and that of the Meter franking is Rs.6/50 (Fig.39).
